



## **ELECTRONIC RECORDS AND SIGNATURES (ESIGN) DISCLOSURE AND ELECTRONIC STATEMENT CONSENT AGREEMENT**

Forbright Bank (we, us, or Company) is required by law to provide to you with certain written notices or disclosures. In some cases, we can provide these notices and disclosures electronically. This ESIGN Disclosure and Electronic Statement Consent Agreement is being provided to you to describe the terms and conditions for providing to you such notices and disclosures electronically. Before you decide whether you wish to provide your consent to receive electronic disclosures, please read and consider the following information.

By agreeing to this ESIGN Disclosure and Electronic Statement Consent Agreement ("ESIGN Agreement"), you agree that Forbright Bank will provide information to you electronically and you agree to the use of electronic records and electronic signatures concerning your account with Forbright Bank. Your ESIGN consent applies to all notices and disclosures, that we may provide to you electronically. Your consent will remain in effect unless you withdraw.

You may also receive account specific online documents electronically (including periodic statements) if you have opted in to do so via our online banking platform.

### **Obtaining Paper Copies**

At any time, you may request from us a paper copy of any record provided or made available electronically to you by us. To request delivery of paper copies of the notices and disclosures previously provided by us to you electronically, please notify us via one of the methods below. In the body of your request, please state your e-mail address, full name, US Postal address, and telephone number. You will not be charged for copies of notices and disclosures.

### **Withdrawing Your ESIGN Consent**

At any time, you have the right to withdraw your consent to receive notices and disclosures, electronically. If you wish to withdraw this consent, please contact us via one of the methods above. Your consent will be updated within 30 days of receipt of your withdrawal. The consequences of your withdrawing consent for these electronic documents may be that some transactions may take longer to process.

### **Withdrawing Your Account Specific Online Documents Consent (via Online Banking)**

You have the right to withdraw your consent to receive online documentation as set up via Online Banking (if applicable). This includes electronic statements, account specific notices and tax documents. To do so, you must change your statement / document preferences in Online Banking back to "paper." (Note: you will not receive an email confirmation upon withdrawing such consent.)

There is a charge for paper statement copies, please refer to our fee schedule.

### Updates to your E-Mail Address

It is your responsibility to keep Forbright informed of your email address to contact you. If there is a change to your e-mail address or where notices and disclosures should be sent, please contact us via email message at: customerservice@forbrightbank.com. In the body of the email, state your previous e-mail address and your new e-mail address. Your request will be deemed submitted upon your receipt of a confirmation email from us. Updates will be made within 30 days.
